NOTE : PAYMENT OF DUES:

As per provision of Section 3, Article IX of By-Laws of the International Constitution & By- Laws, all the Clubs are required to pay their International, Multiple and District Dues atleast fifteen (15) days prior to the date of Multiple Convention, in effect it means, all the Clubs must pay their dues on or before April 16, 2026.

In case of International Dues, it must reach ISAME Secretariat, Mumbai, much before that date so that credit is reflected in the Club Account with LCI. As per Board Policy, if any club has arrears of dues of US\$ 10 and above, it will not be entitled to receive credentials.

Sending of Delegate Forms:

Clubs are required to send their Delegate Forms duly filled in with the name, membership number & photographs of the voting/alternate delegates along with the Registration Charges on or before April 25, 2026 - 4.00 pm. (i.e.) 7 (seven) days before the Multiple Convention as per Article VII Section 1(b) of Multiple By-Laws.

This will enable the Credential Committee to verify and start issuing of the credentials one (1) day before the commencement of the Multiple Convention and close on May 02, 2026 before the presentation of the final report of the Credentials Committee. This is as per Article VII Section 1 (C) of Multiple By-Laws.

The Committee shall scrutinize, redraft, if necessary, the resolutions received from Clubs and present them at the Annual Multiple District Convention. The Clubs proposing resolutions to be moved at the Annual Multiple District Convention shall prepare and forward them in the proper form having passed in the meeting of the Board of Directors of the club and approved by the General Body of the respective Club. The Resolutions proposed by Clubs have to be approved at the concerned District Conventions/Special Convention, where the Club is located before circulation to the Clubs in Multiple District.

The Club proposing the Resolution has to circulate the resolution to all the Clubs in the Multiple District thirty (30) days prior to the convening date of the Annual Convention. The Club should also send the resolution to the Chairperson of the Resolutions Committee with a copy each to the Multiple Council Chairperson and all the members of the Resolutions Committee at least seven (7) clear days before the convening date of the Annual Convention. Any resolution moved by the Multiple Council or Club/Clubs which seeks to amend/modify/ delete/substitute the existing provisions of the Constitution & By-Laws shall be forwarded to the Constitution & By-Laws Committee.

Further, this Committee will draft and present resolutions to be moved at the Annual Convention on behalf of the Multiple Council as approved by the Multiple District Council of Governors.

The Committee will receive, scrutinize, redraft, if necessary, the resolutions seeking to amend or propose change to the Multiple District Constitution & By-Laws and if found them in order present them at the Multiple District Convention. The Clubs proposing Resolutions seeking amendments to be moved at the Annual Convention shall prepare and forward them in the proper form, having passed in the Meeting of the Board of Directors of the club and approved by the General Body of the respective Club and the Sub-District Convention in which the said club is placed. The Club proposing the amendments has to circulate the amendments to all the clubs in the Multiple District fifteen (15) days prior to the convening date of the Multiple District Annual Convention with notice that it shall be voted upon. The Clubs should also forward the same to the Chairperson of the Constitution & By-Laws Committee with a copy each to the Multiple Council Chairperson and all the members of the Constitution & By-Laws Committee at least seven (7) clear days before the convening date of the convention with necessary proof of having circulated to all the Clubs of MD 3242 before the stipulated time of fifteen (15) days.

Any resolution proposing amendments to the Constitution shall require 2/3rd of the votes polled for approval and if it is amendment to the Bye Laws, it shall be approved by a simple majority of votes polled.
